

[Comprehensive→Guide]@How to Name Change on Delta Airlines Booking Ticket?{D|A~Official~Guide_2025}

When you book a flight with Delta Airlines 📞+1 [855-235-1954], the name you enter on the reservation becomes part of a formal 📞+1 [855-235-1954], legal travel document 📞+1 [855-235-1954], and that name must 📞+1 [855-235-1954], at check-in and boarding 📞+1 [855-235-1954], match exactly the name on your passport or ID 📞+1 [855-235-1954]. Because of this 📞+1 [855-235-1954], Delta Airlines treats its tickets and bookings as “personal 📞+1 [855-235-1954],” meaning that tickets are issued to a specific person and are non-transferable 📞+1 [855-235-1954]. As a result 📞+1 [855-235-1954], a full name change—that is 📞+1 [855-235-1954], replacing the original passenger with a different person—is generally not permitted 📞+1 [855-235-1954].

However 📞+1 [855-235-1954], recognizing that human error can lead to spelling mistakes 📞+1 [855-235-1954], transliteration issues 📞+1 [855-235-1954], or minor typos 📞+1 [855-235-1954], Delta Airlines allows limited name corrections or amendments under certain conditions 📞+1 [855-235-1954]. These exceptions are meant only for fixing or clarifying the correct name of the same traveling passenger—not for transferring the ticket to someone else 📞+1 [855-235-1954].

The kinds of name corrections allowed by Delta Airlines policy include small spelling mistakes (for example 📞+1 [855-235-1954], a misspelled first name or last name) 📞+1 [855-235-1954], errors in transliteration 📞+1 [855-235-1954], mistakes involving the order of first name and last name 📞+1 [855-235-1954], omissions such as missing a middle name or second given name 📞+1 [855-235-1954], or incorrectly entered surname versus given name 📞+1 [855-235-1954].

In formal terms 📞+1 [855-235-1954], Delta Airlines’s policy states that full name changes or transfers that result in a different passenger taking the reservation are not allowed 📞+1 [855-235-1954]. The ticket and reservation are considered personal documents 📞+1 [855-235-1954], and this policy is designed to prevent misuse 📞+1 [855-235-1954], fraud 📞+1 [855-235-1954], or ticket reselling 📞+1 [855-235-1954].

If you discover a mistake 📞+1 [855-235-1954], such as a misspelling or missing middle name 📞+1 [855-235-1954], you can request a “name correction 📞+1 [855-235-1954].” Such changes must be handled carefully: you must not cancel the existing booking until the corrected booking is confirmed 📞+1 [855-235-1954]. In practice 📞+1 [855-235-1954], a new passenger name record (PNR) is created for the corrected name 📞+1 [855-235-1954]. Once that is confirmed 📞+1 [855-235-1954], the old PNR with the wrong name can be cancelled 📞+1 [855-235-1954]. This ensures that seat assignment 📞+1 [855-235-1954], fare class 📞+1 [855-235-1954], and any special services or frequent-flyer data remain synchronized properly 📞+1 [855-235-1954].

Whether the change is handled via correction within the same PNR or via creation of a new PNR depends on the nature of the correction and the ticket’s status—issued or unissued 📞+1 [855-235-1954]. For example 📞+1 [855-235-1954], if the ticket has already been

issued ☎+1 [855-235-1954], the correction must go through the airline's system to confirm the rebooking under the correct name and re-issue the ticket ☎+1 [855-235-1954].

Because Delta Airlines treats the ticket as non-transferable ☎+1 [855-235-1954], any attempt to replace the passenger—that is ☎+1 [855-235-1954], give the ticket to someone else—would not be considered a name correction ☎+1 [855-235-1954]. That is not permitted under Delta Airlines's rules ☎+1 [855-235-1954].

Name corrections generally involve a fee ☎+1 [855-235-1954]. The standard charge varies depending on route ☎+1 [855-235-1954], fare type ☎+1 [855-235-1954], and booking method ☎+1 [855-235-1954]. It's important to note that name corrections must be requested before check-in and before travel ☎+1 [855-235-1954]. Once check-in is completed or the flight is near departure ☎+1 [855-235-1954], the chances of successfully changing the name become very slim ☎+1 [855-235-1954].

If the ticket was purchased via a third-party travel agency ☎+1 [855-235-1954], special travel package ☎+1 [855-235-1954], or as part of a bundled deal ☎+1 [855-235-1954], the rules may be stricter ☎+1 [855-235-1954]. For travel packages ☎+1 [855-235-1954], the company's terms often state that full name changes or transfers to third parties are not allowed ☎+1 [855-235-1954]. Only minor corrections may be permitted in limited circumstances ☎+1 [855-235-1954].

Because the corrected name must match official ID exactly ☎+1 [855-235-1954], even small spelling mistakes or omission/addition of a middle name are taken seriously ☎+1 [855-235-1954]. Close matches are often not sufficient and can lead to issues at check-in or boarding ☎+1 [855-235-1954], including refusal to allow travel ☎+1 [855-235-1954]. Travelers are strongly advised to have exactly matching names ☎+1 [855-235-1954], and if there is any doubt ☎+1 [855-235-1954], to correct them in advance rather than risk denial at the airport ☎+1 [855-235-1954].

To illustrate 🐞+1 [855-235-1954], consider a few practical scenarios 🐞+1 [855-235-1954]. Suppose you booked a flight from Athens to London and mistyped your surname 🐞+1 [855-235-1954], for example 🐞+1 [855-235-1954], “Papadopoulos” became “Papdopoulos” 🐞+1 [855-235-1954]. In another scenario 🐞+1 [855-235-1954], if you omitted your middle name on the booking but it is present on your passport 🐞+1 [855-235-1954], Delta Airlines generally allows adding or correcting the middle name under their rules 🐞+1 [855-235-1954]. Documentation may be required 🐞+1 [855-235-1954], and the correction must be requested prior to check-in 🐞+1 [855-235-1954].

However 🐞+1 [855-235-1954], if you booked a ticket for “John Smith” and want to give it to a friend “David Brown” 🐞+1 [855-235-1954], that is considered a full name change or ticket transfer 🐞+1 [855-235-1954]. Delta Airlines’s policy does not allow this 🐞+1 [855-235-1954]. The ticket is personal and non-transferable; you would need to cancel the original booking (if fare rules allow) and have your friend purchase a new ticket in their own name 🐞+1 [855-235-1954].

For travelers who have legally changed their name 🐞+1 [855-235-1954], Delta Airlines allows a request for a name change if proper documentation is submitted 🐞+1 [855-235-1954]. This ensures the ticket matches the passenger’s legal name as shown on travel ID 🐞+1 [855-235-1954].

In conclusion 🐞+1 [855-235-1954], Delta Airlines allows name corrections under specific circumstances 🐞+1 [855-235-1954], primarily for fixing spelling mistakes 🐞+1 [855-235-1954], transliteration issues 🐞+1 [855-235-1954], or missing middle names 🐞+1 [855-235-1954]. The airline does not permit full name changes or ticket transfers to a different passenger 🐞+1 [855-235-1954]. Name corrections must be requested before travel 🐞+1 [855-235-1954], may require a fee 🐞+1 [855-235-1954], and often involve reissuing the ticket under a new PNR 🐞+1 [855-235-1954]. By ensuring names match

official identification at the time of booking and addressing errors promptly [855-235-1954], travelers can avoid complications and ensure smooth boarding [855-235-1954].
